## CASTLE HILL R.S.L. CRICKET CLUB CONSTITUTION

(To be read in conjunction with the Constitution of the Castle Hill R.S.L. Club, the by-laws of this Club and the by-laws of the Cricket Association with which the Club is affiliated.)

- 1. The Club shall be known as the **Castle Hill R.S.L. Cricket Club**, being affiliated under the Castle Hill R.S.L. Club Ltd. constitution and shall be referred to in this constitution as the '**Club**'.
- 2. The object of the **Club** is to promote and encourage participation in the game of cricket and any other activities as seen as fit and proper by the board of directors of the Castle Hill R.S.L. Club Ltd.
- 3. At all times the **Club** shall abide by any direction given by Management on behalf of the Directors of the Castle Hill R.S.L. Club Ltd.
- 4. Members of the Club shall be financial members of the Castle Hill R.S.L. Club Ltd.
- 5. The **Club** shall prepare its own By-Laws and submit them to the Board of Directors of Castle Hill R.S.L. Club Ltd. for approval.
- 6. The Annual General Meeting shall be held within two (2) months of the end of the financial year.
- 7. The financial year shall be 1st July 30th June, to coincide with that of the Castle Hill R.S.L. Club Ltd.
- 8. The Management of the **Club** and custody of its funds and property shall be vested in the Committee of the **Club**.
- 9. The Treasurer shall deposit all monies received in a bank account opened in the name the **Club** with the National Bank of Australia at the Castle Hill Branch. All payments shall be made by cheque. Cheques shall be signed by any two of the President, Treasurer or Secretary or any such person nominated by the **Club**. All monies received shall be receipted.
- 10. A record of all financial members shall be retained and made available for perusal at all times by Management or Directors of the Castle Hill R.S.L. Club Ltd.
- 11. Account Books, Audit Sheets and Financial Members List shall be submitted to the Sports Committee no later than 31st August each financial year to qualify for any grant approved by the Board of Directors of the Castle Hill R.S.L.Club Ltd

- 12. The **Club** shall have the power to fix membership and sporting fees as necessary. It shall be self supporting and financially not reliant on the parent Club.
- 13. The **Club** shall be wholly responsible for its own financial arrangements and indemnifies the Castle Hill R.S.L. Club Ltd from any such responsibility.
- 14. The Club shall appoint two (2) members of its Committee to attend the Sports Committee Meetings which are held on the first Tuesday of the months of March, June, September and December commencing at 7.30pm.
- 15. Any grant received from the parent Club may be used within the Castle Hill R.S.L. Club Ltd as the Club sees fit. The grant may also be used for the direct costs of outside sport of the Club but not entertainment.
- 16. The **Club** will fully co-operate, if called upon by the parent Club, to carry out some duty which is for the benefit of the sporting clubs generally
- 17. If financial assistance is required of the parent Club for an Open Day, the General Manager's approval shall first be obtained and then ratified by the Board of Directors..
- 18. The Club shall purchase and maintain its own equipment for its exclusive use.
- 19. A list of the Club's office bearers for the current year must be forwarded to the Sports Committee by the 15th September each year and whenever a change occurs.
- 20. A copy of the Club's By-Laws will be forwarded to the Sports Committee as information. These By-Laws will not include or conflict with items or subjects listed in this document or the constitution of the Castle Hill R.S.L. Club Ltd.
- 21. Cash prizes for competitions are not permitted.
